The Annual General Meeting of the Equity Shareholders of Sellwin Traders Limited held on 27th day of September, 2021 at 2:00 P.M. through video conferencing ("VC")/ Other Audio Visual means ("OAVM").

- 1. I, Aditya Kumar Daga, Practicing Company Secretary (Membership No. F10573 & Certificate of Practice No. 14266) has been appointed as the Scrutinizer by the Board of Directors of Sellwin Securities Limited (the Company) for the purpose of:
- Scrutinizing the e-voting process (remote e-voting) under the provisions of Section 108 of the Companies Act, 2013 (the 2013 Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended (Rules).
- 2. The Management of the Company is responsible to ensure the Compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic means [i.e. by remote e voting at the AGM] for the resolutions contained in the Notice to the Annual General Meeting (AGM) of the Equity Share Holders of the Company. My responsibility as a Scrutinizer for the voting process of voting through electronic means (i.e. by remote e-voting at the AGM) is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolution stated above, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited. (CDSL), the Agency authorized under the Rules and engaged by the Company to provide e-voting facilities for voting through electronics means (i.e. remote e-voting).
- 3. The Company had appointed Central Depository Services (India) Limited (CDSL) as the service provider, for extending the facility of electronic voting to the shareholders of the Company from 24th September 2021 (9.00 A.M. IST) to 26th September 2021 (5.00 P.M. IST).



- 4. Since due to Covid-19 pandemic, the Management has decided to conduct the Annual General Meeting through Video Conferencing/Other audio-Visual means)"VC"/"OAVM". Hence members are allowed to vote only through elctronic mode, and no opportunity of Ballot voting was provided to the members.
- 5. I unblocked the remote e-voting results on the NSDL e-voting platform before Mr. Tarun Somani and Mr. Sajahan Baidya and downloaded the e-voting results (both are not in employment of the Company). They have signed below in confirmation of the votes being unblocked in their presence.
